

**COUNTY-CITY CREDIT UNION BIG SAVERS CLUB SWEEPSTAKES
OFFICIAL RULES**

- 1. NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.**
- 2. ELIGIBILITY:** Open only to members of County-City Credit Union, or individuals who meet County-City Credit Union's membership eligibility requirements at time of entry. Open only to legal residents of the United States, age 13 or younger, at time of entry. Employees and volunteers of County-City Credit Union, and their immediate family are not eligible. Void where prohibited and subject to all applicable federal, state and local laws.
- 3. PROMOTIONAL PERIOD:** Sweepstakes begins at 12:01 AM Central Time on January 1, 2020 and ends at 11:59 PM Central Time on December 31, 2021.
- 4. TO ENTER:** There are three ways to enter the sweepstakes: **1) Automatic Entry:** Participants will automatically receive one (1) entry each time they submit a completed Big Savers Club stamp card with their first and last name written on the back, and with the required five (5) official credit union stamps acquired for making 5 separate deposits, each totaling at least five US dollars (\$5). Youth Member must be present at the time of the transaction to earn stamps. Members are responsible for their own stamp cards. CCCU is not responsible for the loss of any stamp cards. Automatic entries must be made during promotional period to be eligible. Other restrictions may apply. **2) Promotional Entry:** Participants may additionally receive entry for participating in periodic Big Savers Club promotions as separately disclosed by the credit union. **3) Enter by U.S. Mail Without Making a Purchase:** Entrant's name, address, city, state, ZIP code, and daytime and evening telephone numbers (including area code) must be hand-printed on a 3" x 5" card, and mailed in a #10 envelope with postage affixed, to: County-City Credit Union, 106 E John St, Jefferson WI 53549. Each mail-in entry will count as one (1) entry into the drawing. Mail-in entries must be postmarked by December 31, 2021 and received by January 5, 2022 to be eligible. Enter as often as you wish; however, each mail-in entry must be mailed in a separate, postmarked-and-stamped envelope. Entries that are mechanically reproduced, copied, illegible, incomplete, postage-due or inaccurate, or by any means subvert the entry process are void. Entries become the property of County-City Credit Union and will not be acknowledged or returned. Incomplete entries or entries not complying with these Official Rules are subject to disqualification at County-City Credit Union's sole discretion.
- 5. DETERMINATION OF WINNER:** Potential winner will be selected in a random drawing on or about January 7, 2022, from among all eligible automatic and mail-in entries received and combined. Random drawing will be conducted by County-City Credit Union under dual control by two authorized credit union representatives. Potential winner will be notified by telephone and/or U.S. Mail within five (5) days of drawing. Inability to contact potential winner within a reasonable time period at phone number and address on record, will result in potential winner's disqualification and, at County-City Credit Union's sole discretion, the awarding of the prize to a potential alternate winner.
- 6. PRIZE DESCRIPTION: One (1) Grand Prize:** One (1) Single Adult Family Milwaukee County Zoo Pass. This Zoo Pass includes unlimited free zoo admission for the year 2022 for one (1) parent/grandparent, their minor children/grandchildren (17 yrs. and younger), and one (1) guest. This Zoo Pass also includes free parking for one (1) vehicle per day, gift shop discounts, Alive Magazine subscription and Wild Things Newsletters, admission to member-only events and field trips, Education Camp/class discounts, and free or reduced admission to over 150 other zoos and aquariums. **(Total Approximate Retail Value ("ARV") of the Grand Prize is \$170.00 as of 03/01/2021).** No substitutions, cash equivalents, or transfer of prize will be permitted, except at the sole discretion of County-City Credit Union, which reserves the right to substitute prize with one of comparable or greater value at its sole discretion. All federal, state, and local taxes, and any other costs and expenses associated with prize acceptance and use are the sole responsibility of the winner. - 7. ODDS:** Estimated odds of winning the Grand Prize are 1:100; however, the actual odds of winning depend upon the total number of eligible entries received.

By consenting to allow the minor to participate in the Big Savers Club Sweepstakes, the minor's legal guardian(s) release and hold County-City Credit Union harmless from any claims, actions, personal injury, death, loss, or damage of any kind, resulting (directly or indirectly, wholly or in part) from participating in this Sweepstakes or from the acceptance, possession, use or misuse of prize (including travel/activity related thereto). County-City Credit Union is not responsible for lost, late, illegible, misdirected, inaccurate, incomplete, undelivered, damaged, delayed, or non-received entries. County-City Credit Union may, in its sole discretion, void any entries it suspects impair the fairness or integrity of the sweepstakes. Any attempt by an entrant or other individual to damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and, should such an attempt be made, County-City Credit Union reserves the right to seek damages and other remedies (including attorneys' fees) from any such person to the fullest extent permitted by law. Except where prohibited, all issues and questions concerning these Official Rules, or the rights and obligations of participants and County-City Credit Union in connection with the sweepstakes, shall be governed by the laws of the State of Wisconsin. Jurisdiction and venue shall be solely within the state of Wisconsin.
